A certified copy means a document that has been certified as a true copy of an original document

The certifier is required to

1. Stamp or write on the copy: "This is a true copy of the original documents sighted by me."
2. Sign and print their name, and affix an official stamp where applicable.
3. State their profession or occupation group.
4. Write on the copy the date certified

The following list is individuals who have the qualifications and are eligible to certify copies of ID documents

- Medical practitioner
